On September 14, 2019, a meeting was held at the Clubhouse to discuss the potential of forming a new Social Committee. John Stover facilitated the meeting and seven owners were in attendance. The previous Social Committee formally disbanded in March of this year. John discussed Social Committee documents that showed a steady decline over the years in not only the number of volunteer committee members but also community attendance at the organized events. There was open discussion as to possible reasons for this decline. Those included: 1.) A larger owner age gap than there was 30 years ago when the original Social Committee was formed. 2.) A much larger availability of activities outside the VOG community including theaters, restaurants, the mall, ball parks, and frequent local events throughout Pinellas County. 3.) Newer VOG residents might like some other themes for events rather than the same ones which have been done repeatedly over the last 30 years.

Although no new Social Committee was formed at this meeting, those individuals who attended suggested that a survey be distributed to help determine what current VOG residents are looking for. Also, these attendees made a few suggestions for events including a "Meet & Greet Coffee Hour" and an "Oktoberfest" themed potluck event for the month of October. There will be a follow-up Social Committee Interest meeting on Wednesday October 16, 2019 at 10:30 a.m. Any interested VOG owners are encouraged to attend. The success or failure of any new committee will depend upon the number of individuals willing to actively participate and input from the VOG community.
